### **City of Post Falls Updates:**

---

- City Hall was opened to drop in customers today with limits on the number of visitors allowed in each department at one time. A finance employee is staffing a desk in the rotunda to answer questions, take utility payments, and monitor the number of visitors.
- Staff is working with Panhandle Health District regarding restaurant reopening plans and how non-compliance will be handled. There is some question as to the definition of a restaurant vs. a bar. Once all the information is gathered and approved, a summary will be forwarded to everyone and put on the City's website so the information is readily available to answer any of the public's questions. #### **From Ron Jacobson, Mayor of Post Falls**
